If at least 54 applications are received for the Los Trancos Woods project, CSCDA will commence the proceedings to include the project in the SCIP program and at that point the \$500 application fee will become non-refundable; however the amount of the fee will be applied to pay a portion of the costs of issuance of the bonds thereby reducing the ultimate assessment to each participating property owner. In the event less than 54 applications are received by CSCDA by the deadline of May 6, 2005, \$400 of the fee will be refunded to each applicant and the remaining \$100 will be retained by CSCDA to defray costs.
